This has reference to your online application bearing registration no EX-02635-1819 on the above subject.

In this regard, the following deficiencies / requirements have been observed during the scrutiny of your application:-

- As per online application, 02 teachers working in the school are untrained. The school is required to appoint trained & qualified teachers to maintain section teacher ratio i.e. 1:1.5 teachers per section at each level. Hence, a copy of revised staff statement is required to be submitted showing Name, Qualification, Experience, Designation, Date of Appointment, Date of Confirmation etc.
- The school is required to submit a list of enrolment of students class/section wise. As per Affiliation Bye-laws of the Board the optimum strength of a section should not exceed more than 40 students.
- The school is required to furnish valid Health & Sanitary, Safe-Drinking Water, Building Safety, Fire Safety and Transport Safety Certificates issued by the competent authorities/concerned department.
- School Managing Committee is to be re-constituted as per Rule 20 of Affiliation Bye-laws of the Board. The school is required to submit an affidavit duly notarized regarding 'No relation' exists among SMC members.
- The school is required to submit certificate from the State Education Department to the effect that the school is paying salary to its staff as per norms of the State Government.
- The school is required to submit certificate from the State Education Department to the effect that the school is paying salary to its staff as per norms of the State Government.
